2011 APPLICATION FOR VEHICLE STICKERS & PET LICENSES

2011 Vehicle stickers must be **purchased & displayed** by **March 31**. This regulation applies to all vehicles that are licensed by the State & housed in the city of Prospect Heights.

-City accepts cash, checks, or money orders (payable to - City of Prospect Heights). Debit or Credit Cards only accepted when using E-Pay (via website), they are NOT accepted at City Hall.

- If mailing, dropping off, or On-Line Payment, the application will be processed then your vehicle sticker(s) &/or pet license(s) along with a receipt will be mailed back to you. For all payments by mail, drop off, or E-Pay, you must include \$1.00 extra for postage & handling (P&H).

- Come in person with this completed application Monday through Thursday, 8:30 am – 4:30 pm, to City Hall;

- Drop off this completed application along with your payment and include \$1.00 extra for P&H, in the 24-hour green, drop-off mailbox located by the west front entrance door at City Hall, 8 N Elmhurst Rd.;

- Mail this completed application, along with your payment & include \$1.00 extra for P&H to: City of Prospect Heights Attn: Vehicle Stickers, 8 N Elmhurst Road, Prospect Heights, IL 60070.

- Sticker for a NEW CAR within 30 days of purchase or NEW RESIDENT within 30 days of residency – there is no penalty. PROOF OF NEW CAR PURCHASE/NEW RESIDENCY MUST BE PROVIDED (ex. Bill of sale, lease agreement, closing documents).

- Dogs & Cats over 4 months of age must have their rabies shot & are required to be licensed with the City. A certificate of inoculation for rabies must accompany this application.

2011 APPLICATION FOR RESIDENTIAL / BUSINESS ALARM LICENSE

In accordance with City Ordinance 0-99-21, all alarm systems operating within the City of Prospect Heights must be registered with the Prospect Heights Police Department.

- The initial alarm registration fee is \$50 with an annual renewal fee of \$40 every year thereafter.
- To avoid additional alarm response charges and the expenditure of public funds by diverting emergency equipment and personnel, we ask that you assist us by maintaining your alarm system to prevent all false alarms.
- If you have incurred any chargeable alarm fees during the calendar year, these charges must be paid in full. These charges are invoiced throughout the year.
